## AN ORDINACE ESTABLISHING THE 2023 TAX YEAR LEVY AVON TOWNSHIP, LAKE COUNTY, ILLINOIS

BE IT ORDAINED, by the Trustees of Avon Township, Lake County, Illinois:

**SECTION 1.** That the one million, nine hundred and five thousand, nine-hundred thirteen dollars (\$1,905,913) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund General Assistance Fund General Road Fund Permanent Road Fund

For the tax tear 2023, collectable in 2024.

**SECTION 2.** That the amount levied for each object and purpose shall be as follows:
