ORDINANCE NO. 2023-OR-003

BE IT ORDAINED, by the Trustees of Avon Township, Lake County, Illinois:

SECTION 1. That the one million, nine hundred and five thousand, nine-hundred thirteen dollars (\$1,905,913) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund
General Assistance Fund
General Road Fund
Permanent Road Fund

For the tax year 2023, collectable in 2024.

SECTION 2. That the amount levied for each object and purpose shall be as follows:

SECTION 4. That if any section, sentence, or subdivision of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portions of this ordinance.
